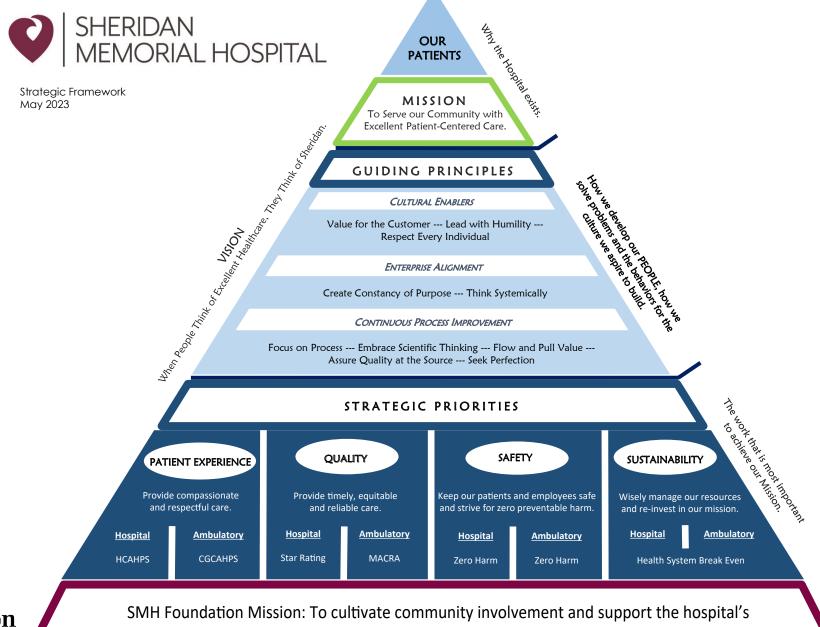

# **WELCOME:**

President Sue Belish called the meeting to order at 4:00 pm and welcomed everyone. She reminded the Board of the importance of following the Strategic Plan and the importance of following HIPAA, which helps keep patients safe.

## SHERIDAN MEMORIAL HOSPITAL UPDATE

Cody Sinclair introduced Joe Wright, Chief Operating Officer. Joe discussed the process and timeline of the current Construction Projects. The projects and funding began in 2022 when the State of Wyoming designated funds for mental health. O'Dell won the bid and has done an amazing job of meeting deadlines and staying within budget. The Construction Project consists of three phases. Phase 1 was repurposing the lower level of the hospital and creating a new In-Patient Pharmacy and Supply area. Phase 1 was completed July 2024. Phase 2 involves moving Pediatrics to the old Pharmacy area. The new Pediatric Unit construction will be completed by February 2025. The old Pediatrics will be repurposed creating additional rooms for Med Surg. Phase 3 will be the construction of the Behavioral Health Unit..

## FUNDRAISING/PHILANTHROPY BEST PRACTICE:

Cody Sinclair introduced Robbi Morris, Sheridan Memorial Hospital Compliance Officer. As a Compliance Officer, Robbi ensures the hospital follows all the relevant laws and regulations to maintain the highest quality of care. It involves monitoring clinical practices and addressing issues that may compromise patient safety. Robbi discussed HIPAA (Health Portability and Accountability Act) and Confidentiality Education. HIPAA establishes standards for protecting health information and preventing unauthorized disclosure. Robbi emphasized the importance of Board Members following the HIPAA guidelines and being mindful of the special roles they have within the hospital.

Liz Dearcorn updated the Roadmap for Philanthropic Support for the SMH's Strategic Plan as seen on page 16 of the August 2024 Board Packet. As of August 31, 2024, The Foundation has collected

Jasmine Slater gave the Community Coordination, Event & Volunteer updates. The following events are:

"100 donors in 100 days" Campaign began August 26, 2024 and will continue to December 4, 2024. The campaign aims to bring the community together to support the development of the Behavioral Health Unit. Nineteen gifts totaling over \$70,000 have been received for the campaign as of September 23, 2024.

Green House volunteers will have orientation along with all other SMH Volunteers on October 10, 2024. This is the same time flu and COVID vaccinations will be available to all volunteers.

The Link information will be mailed to 2,550 addresses on September 25, 2024. The Link walk/run is scheduled for Saturday, October 19, 2024 and the goal is to raise funds for comfort care for patients at the Welch Cancer Center.

Richard Garber shared what a pleasure it is to have Dr. Scott working at the Hospital and continually being a positive force. The Greenhouse received permits to update various areas throughout the facility. Currently, there are 25 patients in the facility. The Greenhouse is accepting private paying individuals and is waiting for Medicare approval to accept more patients. The new clinic on Sugarland is scheduled to open November 11, 2024.

# SMH PHYSICIANS- DR.JOSH SCOTT

Dr. Scott shared that the Medical Staff had their quarterly meeting in September. New officers were elected for the upcoming calendar year. Dr. Megan Ratterman was elected the Chief of Staff and Dr. David Walker was elected Vice Chief of Staff. At the Med Staff meeting, Dr. Scott also shared with his colleagues about the wonderful projects that The Foundation has completed and how it continues to support the Hospital in all the areas of need.

# **SMH AUXILIARY- ROSEMARY RIEDER**

Rosemary was absent so Jasmine Slater gave a quick report. The 5-year-old Birthday Party, held September 21, was a great success. Over 15 high school volunteer students helped along with many of the Auxiliary volunteers. The Auxiliary will now start working on the Trees of Love held in December.

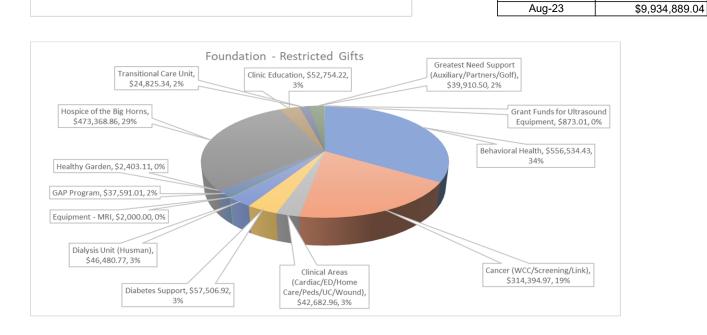
