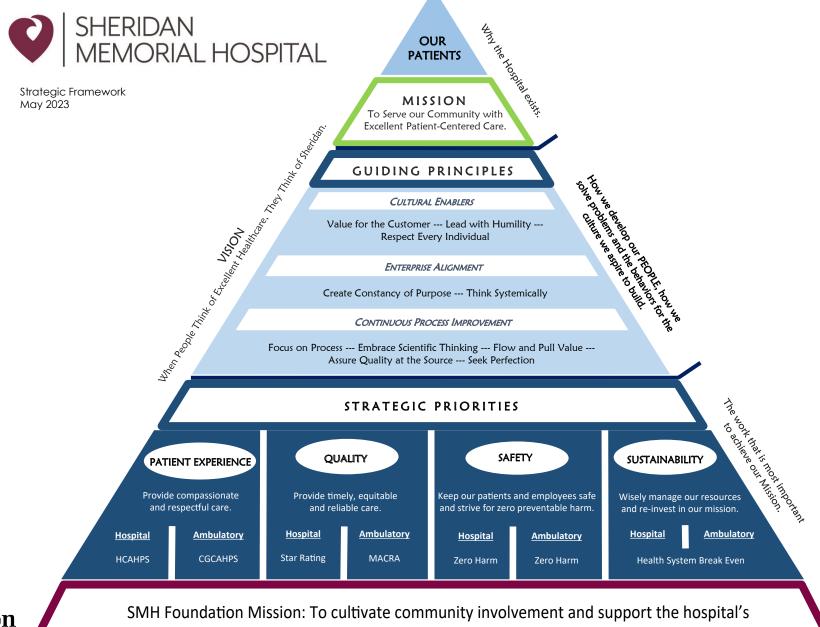

WELCOME:

President Sue Belish called the meeting to order at 4:00 pm and welcomed everyone. She reminded the Board of the hospital's mission "To serve our community with excellent patient-centered care." and The Foundation's role in supporting this work. Sue shared stories from recent Sheridan Memorial Hospital monthly newsletter, highlighting staff and volunteers who exemplify the mission.

SHERIDAN MEMORIAL HOSPITAL UPDATE

Cody Sinclair introduced Mike McCafferty, Chief Executive Officer. Mike gave an update on Growing for You efforts and the anticipated need for additional financial support for the Behavioral Health once costs are finalized. Mike also shared that we are a County Memorial Hospital and do not receive tax funding (mill levy) from Sheridan County.

Cody introduced Kristen Czaban, the Director of Marketing and Communications and Brittany Goodvin, the Behavioral Health Director. Kristen spoke about the intentional naming of the Behavioral Health Unit. The goal of the name is to be a welcoming name that provides a warm and friendly environment and a personal feel. "The Maggie" was suggested because Margaret "Maggie" Partridge struggled with mental health and paralysis and spent over 20 years as a patient at Sheridan Memorial Hospital. She became close to the staff and in particular Dr. Sy Thickman. Despite her struggles, she was a valuable asset to the community and her story is timeless and relatable.

FUNDRAISING/PHILANTHROPY BEST PRACTICE:

Cody Sinclair introduced Kristin Wilkerson, VP Wealth Advisor at First Interstate Bank. She talked to the Board about Non-Profit Board Responsibilities. She reviewed the areas of Board Fiduciary Responsibilities. A copy of her presentation is filed with the minutes.

PHILANTHROPIC STORY-ADA KIRVEN

Ada shared the story of how Dr. Milner and the Sheridan Hawks Jr Hockey Team became involved with The Link. It has been a great partnership for the last five years, cumulatively raising over \$15,000.00 in support of Welch Cancer Center Programs. While the Hawks players were at an away game during The Link, they still participated by walking together in their Pink Link t-shirts.

CONSENT AGENDA (action):

Sue Belish presented the two items on the consent agenda (September 23, 2024 meeting minutes and September 2024 Checks, Transfers, and Journal Entries) and called for a motion. There were no questions or concerns.

RYAN FRANKLIN MOVED TO APPROVE THE CONSENT AGENDA. DR. DOUGHTY SECONDED THE MOTION. THE MOTION CARRIED UNANIMOUSLY.

FOUNDATION REPORTS

Ada gave an update on Donor Relations as seen on page 12 of the October 2024 Board Packet. There are 67 new donors to date this year, 14 major gifts, and \$186,239.00 received in new cash/stock.

Liz Dearcorn updated the Roadmap for Philanthropic Support for the SMH's Strategic Plan as seen on page 14 of the October 2024 Board Packet. As of September 30, 2024, The Foundation has collected in pledges and gifts for the Growing for You Campaign a total of \$57,177 over the original \$15 million campaign goal.

Jasmine Slater gave the Community Coordination, Event & Volunteer updates. The following events are:

"100 donors in 100 days" Campaign began August 26, 2024 and will continue to December 4, 2024. The campaign aims to bring the community together to support the development of the Behavioral Health Unit and wants to emphasize that every dollar counts.

The Link walk/run was held on Saturday, October 19, 2024. Approximately \$56,000.00 was raised for comfort care for patients at the Welch Cancer Center. The 16th Link walk/run was a huge success with over 520 participating of all ages and demographics.

The Auxiliary will begin the hospital's holiday setup on November 14 and 15th. November 18th will be the Gift Shop Open House and December 8th will be the Trees of Love community celebration. The Greenhouse patients will also provide new artwork through the Opening Minds through Art (OMA) program at the Trees of Love Ceremony.

Ryan Franklin gave the Quarterly Finance Report. He mentioned that when the CD's expire, they will be moved into checking accounts because the interest rate is better with those accounts.

Dr. Doughty gave the Quarterly Donor and Fundraising Committee Report. The committee met October 22 and welcomed new Board Members to the committee, reviewing the work done over the last three months to engage with our community.

Richard Garber shared the value and importance of staying on course for raising funds for the

Behavioral Health Unit. He also mentioned that naming the Behavioral Health Unit is so important in creating a welcoming environment.

Dr. Scott was not present to give a report.

SMH AUXILIARY- ROSEMARY RIEDER

Rosemary Rieder was not present but Jasmine Slater gave an update on the Auxiliary events.





We are extremely blessed to live in a community such as ours, with an abundance of skilled and community minded leaders who work tirelessly to support our mission. The work you have done to date in support of our Behavioral Health Unit has been tremendous and we are eternally grateful.

We appreciate the opportunity to provide you with information in support of our efforts to strengthen behavioral health services in Sheridan and the region. As you know, we have experienced inflationary pressures that have significantly increased the cost of our project.

As we have progressed through the phases of this project, we have seen skyrocketing post pandemic construction industry inflation. Inflation costs from the original project estimate have resulted in a 29% increase, approximately \$3 million, which aligns with the American Institute of Architects assessment that the construction industry has experienced cost increases of 35-40% pre-pandemic rates.

We recognize that you have exceeded our initial estimated request and with the challenges we have outlined above, we are requesting The Foundation's consideration of continued fundraising for the Behavioral Health Unit. Specifically, we are asking for your assistance in raising an additional \$2 million over the next two years.

Thank you very much for this consideration of continued support from The Foundation to effectively address the needs of the Sheridan community and the region.
