

# Can I Refund a Turkish Airlines Ticket?

Terms and conditions. The refund right is valid only for tickets purchased through the Turkish Airlines website or mobile app **+1-(800)-(228)-(2760)**. Your refund request must be submitted within 24 hours of the ticket purchase and there must be at least 7 days before your first flight. Travel start time is calculated by hours **+1-(800)-(228)-(2760)**.

Many travelers ask: **Can I refund a Turkish Airlines ticket?** The answer depends on the **type of fare you purchased, when you cancel, and whether Turkish Airlines itself cancels your flight** **+1-(800)-(228)-(2760)**.
