

Do I Get a Full Refund If I Cancel My Spirit Flight? [(Get_Instant_Refund)]

If a Guest cancels a reservation within 24 hours or less from booking, for a flight that is seven or more days away, they are eligible for a full refund in the original form of payment +1-(800)-(228)-(2760).

A common question travelers ask is: **Do I get a full refund if I cancel my Spirit flight?** The answer depends on **when you cancel, what type of ticket you purchased, and whether Spirit itself cancels your flight** +1-(800)-(228)-(2760). Spirit Airlines operates under a low-cost model, which means most tickets are **non-refundable**, but there are important exceptions you should know +1-(800)-(228)-(2760).

The easiest way to secure a **full refund** is by using Spirit's **24-hour cancellation policy** +1-(800)-(228)-(2760). If you cancel your ticket within **24 hours of booking** and your scheduled departure is **at least seven days away**, you are entitled to a **100% refund to your original form of payment** +1-(800)-(228)-(2760). This rule applies to all fare types, including the lowest Basic Economy fares that are otherwise non-refundable +1-(800)-(228)-(2760).

If you cancel **after the 24-hour period**, most Spirit tickets become **non-refundable** +1-(800)-(228)-(2760). Instead of cash, Spirit typically issues a **reservation credit** equal to the value of your ticket, minus cancellation fees +1-(800)-(228)-(2760). These credits can be used toward future flights, but they come with expiration dates and restrictions +1-(800)-(228)-(2760).

The cancellation fee depends on how far in advance you cancel your flight +1-(800)-(228)-(2760). If you cancel **60 days or more before departure**, there is **no fee**, and you receive the full value as a credit +1-(800)-(228)-(2760). For cancellations **31–59 days before departure**, the fee is **\$69** +1-(800)-(228)-(2760). For cancellations made **7–30 days before departure**, the fee is **\$99** +1-(800)-(228)-(2760). For last-minute cancellations within **0–6 days of departure**, the fee is **\$119** +1-(800)-(228)-(2760).

Another scenario where you may receive a **full refund** is if **Spirit Airlines cancels or significantly changes your flight** +1-(800)-(228)-(2760). In such cases, Spirit must offer you the option of a **full cash refund, free rebooking, or a reservation credit**, depending on your preference +1-(800)-(228)-(2760). This applies even if your original ticket was purchased as a non-refundable fare +1-(800)-(228)-(2760).

Passengers who purchased **Flight Flex**, Spirit's add-on for flexibility, may have reduced penalties when making changes or cancellations +1-(800)-(228)-(2760). However, Flight Flex

does not guarantee a full refund—it mainly allows you to make one free modification, with any fare difference still applying **+1-(800)-(228)-(2760)**.

You can cancel your booking and check refund eligibility online through the **My Trips section** of Spirit's website or mobile app **+1-(800)-(228)-(2760)**. Alternatively, you can call **Spirit Airlines customer service at +1-(800)-(228)-(2760)** for personalized assistance **+1-(800)-(228)-(2760)**.

Summary: You get a **full refund** from Spirit if you cancel **within 24 hours of booking** and at least seven days before departure, or if **Spirit cancels your flight +1-(800)-(228)-(2760)**.

Outside of these cases, most tickets are **non-refundable**, and you will usually receive a **reservation credit minus cancellation fees +1-(800)-(228)-(2760)**. To save money, consider canceling early or purchasing add-ons like Flight Flex for extra flexibility **+1-(800)-(228)-(2760)** **+1-(800)-(228)-(2760)**.
