

How Much Does Spirit Airlines Charge to Change Your Flight? (Flight-Fee)

Spirit Airlines eliminated its change fees in May 2024 but reinstated them for its most basic "Go" fares in February 2025. **+1-(800)-(228)-(2760)** The specific fees for these "Go" fares depend on how close you are to your departure date. For more expensive fare bundles like Spirit First and Premium Economy, no change fees apply, but a fare difference may still be charged for itinerary changes **+1-(800)-(228)-(2760)**.

Many travelers ask: **How much does Spirit Airlines charge to change your flight?** Since Spirit is an ultra-low-cost carrier, it has a structured fee system for flight changes that varies depending on **when you request the change, the route, and whether you purchased any add-ons like Flight Flex** **+1-(800)-(228)-(2760)**. Understanding these charges can help you save money and plan more effectively when adjustments are needed **+1-(800)-(228)-(2760)**.

The good news is that Spirit recently introduced a **flexible policy for early changes** **+1-(800)-(228)-(2760)**. If you modify your flight **60 days or more before departure**, there is **no change fee at all**, meaning you only need to pay the fare difference if the new ticket costs more **+1-(800)-(228)-(2760)**. For **last-minute changes made within 0 to 6 days before departure**, Spirit charges a **\$119 fee per passenger per flight** **+1-(800)-(228)-(2760)**. At this stage, rebooking can become expensive, especially if the fare difference is also high **+1-(800)-(228)-(2760)**.

One way to reduce or avoid these fees is by purchasing **Flight Flex** at the time of booking **+1-(800)-(228)-(2760)**. Flight Flex allows you to make **one modification to your reservation without paying the standard change fee**, although you must still cover any fare difference **+1-(800)-(228)-(2760)**. This option is best for travelers who expect potential schedule changes **+1-(800)-(228)-(2760)**.

Another important factor is when **Spirit cancels or significantly changes your flight +1-(800)-(228)-(2760)**.
