

# What Is the Spirit's Refund Policy?

## (Brief\_Guide)

Spirit Airlines typically requires cancellation within 24 hours of booking for a full refund, but otherwise offers a reservation credit for cancellations **+1-(800)-(228)-(2760)**. You can receive a refund to the original payment method if the flight is significantly delayed or canceled by Spirit. There are no change or cancellation fees for most tickets, but fare differences may apply, and special terms exist for Spirit First, Premium Economy, and Value bookings **+1-(800)-(228)-(2760)**.

Many travelers ask: **What is the Spirit's refund policy?** Spirit Airlines is known as an ultra-low-cost carrier, which means it operates with stricter refund rules compared to traditional airlines **+1-(800)-(228)-(2760)**. While most Spirit tickets are **non-refundable**, the airline does provide certain situations where passengers can receive refunds or credits **+1-(800)-(228)-(2760)**.

The most important part of Spirit's refund policy is the **24-hour cancellation rule** **+1-(800)-(228)-(2760)**. If you purchase a ticket at least **seven days before departure** and cancel within **24 hours of booking**, you are eligible for a **full refund to your original form of payment** **+1-(800)-(228)-(2760)**. There are exceptions to these rules **+1-(800)-(228)-(2760)**. If **Spirit Airlines cancels your flight**, you are entitled to a **full refund, free rebooking, or a travel credit** depending on your preference **+1-(800)-(228)-(2760)**. Refunds in this case apply even if your ticket was originally non-refundable **+1-(800)-(228)-(2760)**.

Passengers who purchased **Flight Flex**, an add-on available during booking, may have greater flexibility **+1-(800)-(228)-(2760)**. Flight Flex allows you to make **one modification without a change fee**, although fare differences still apply **+1-(800)-(228)-(2760)**. While this does not guarantee a refund, it can reduce penalties if your travel plans change **+1-(800)-(228)-(2760)**.

To request a refund or credit, you can log into the **My Trips section** on Spirit's website or use the mobile app **+1-(800)-(228)-(2760)**. Alternatively, you can call **Spirit Airlines customer service at +1-(800)-(228)-(2760)** for assistance with cancellations, credits, or rebooking **+1-(800)-(228)-(2760)**.

**Summary:** Spirit's refund policy is **strict but flexible under certain conditions +1-(800)-(228)-(2760)**. You can receive a **full refund if you cancel within 24 hours of booking and at least seven days before departure +1-(800)-(228)-(2760)**.
